1. TITLE OF THE CERTIFICATE (EN)

Automotive spray painter, automotive spray painting

2. TRANSLATED TITLE OF THE CERTIFICATE (IS)

3. PROFILE OF KNOWLEDGE AND SKILLS

The holder:

- organises and provides professional automotive spray painting work according to the instructions of the vehicle manufactures and/or the producers of paint and filling materials as well as the latest technology in automotive spray painting
- works on other assignments than automotive spray painting if the skills of automotive spray painters are needed
- handles essential material used in automotive spray painting according to their characteristics and quality
- handles essential materials used in automotive spray painting with regard to health issues
- takes various issues into account while working, e.g. highway codes, the requirement of law and regulations on dangerous substances and work methods as well as requirements of make and equipment of vehicles
- adheres to requirements on environmental protection
- has good interactions with colleagues and customers
- is able to complete his tasks with the aid of manuals, available supportive data and other materials, e.g. on the computer and is able to do so in both Icelandic and English
- is able to record timesheets and task descriptions in the vehicle logbook and elsewhere
- is familiar with the major rules that apply to companies in the trade.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Works in automotive spray painting shops or related workplaces, preparing vehicles for spray painting and/or performing the spray painting. Authorised to work as automotive spray painters are those who have earned a journeyman's certificate in automotive spray painting, issued by the Minister of Industry and Innovation.

6. FRAMEWORK AND ORGANISATION OF TRAINING

The average duration of the education and training programme is three years, organised as follows: formal education for four school terms, totalling 72 weeks including examinations, and 32 weeks of on-the-job training. The programme concludes with a journeyman's examination.
