Update on the OLA/DLA timeline

- ❑ OLA/DLA (EWP) mandatory from June 2021
- ❑ Change in timeline: OLA/DLA (EWP) now mandatory for all study mobilities independent of Call year
- ❑ Erasmus traineeship and ICM-mobility will be developed and added at a later date
- ❑ All HEIs should connect to the EWP network as soon as possible, and at the very latest before the first mobilities in the academic year 2022/2023 (exceptional cases)
- ❑ In exceptional cases, higher education institutions can continue to use their own DLA systems (or paper version) until they are connected to the EWP network, but the minimum requirements in the new LA-template for the new programme period is mandatory
- ❑ If there is a delay in the EWP connection, HEIs *can* use the Dashboard, but it is not recommended to use Dashboard **merely** as an interim solution


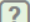





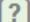

University of Helsinki – Mobility Online

- We had to start by looking at our application process and if it was compatible with the new DLA plans
- Find a solution that could be smooth both for students and staff
- Prepare as far as we could before the ewp-connection actually works
- Active discussion with the system provider

Haaga-Helia University of Applied Sciences - MoveON

- We have been using Dashboard for OLA since 2020
- Plan to implement OLA in MoveON by end of April 2021
- LA template with EWP connection already available in MoveON (and being tested)
- Challenges in the transition period:
 - Define the time when we will change from Dashboard to MoveON
 - Not possible to use both at the same time for data exchange
 - OLA for Spring 2021 mobilities in Dashboard, for Autumn 2021 in MoveON
- Benefits of using MoveON instead of Dashboard:
 - All documents in one place
- Students can access all their workflow in the same system
