3. DESCRIPTION OF KNOWLEDGE AND SKILLS

The holder

- has an extensive specialised knowledge on plant species suitable for cultivating in Iceland
- selects and implements the cultivation methods best suited in each instance and applies cultivation techniques to solve problems that can arise in the production. Is responsible for the quality of the plants he produces
- makes cultivation plans for plant production suitable for Icelandic conditions and follows them up. This includes the selection of species and varieties, propagation methods, appropriate soil, nurturing inside and outside greenhouses, sizes of flowerpots, appropriate fertilisation and irrigation and how to combat vermin and diseases
- organises cultivation areas in a practical and efficient way. Is aware of the environmental effects and knows how to prevent unfavourable impacts
- makes independent decisions and advises on the selection and treatment of plants
- is able to communicate both verbally and in writing about the current situation and the future of the profession from a professional view point
- is able to make business plans and organise and run or manage a horticultural business or other businesses profitably
- observes safety in the workplace, by using personal protection, etc.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A horticulturalist specialising in plant production works with the production of plants and trees. He/she either runs his/her own business or works in a garden or tree cultivation establishment or for a municipality, usually as a supervisor or in charge of cultivation. He/she is responsible for the selling of plants and advises customers on everything regarding plant cultivation in gardens or open areas.

6. FRAMEWORK AND ORGANISATION OF TRAINING

<p>The study programme for horticulturalists specialising in plant production is divided into four terms of academic studies at the Department of Vocational training and Lifelong learning at the Agricultural University of Iceland at Reykir in Ölfus and vocational training for 72 weeks at a recognised workplace supervised by a vocational teacher. A journal which makes a part of the final grades must be kept for 60 out of the 72 weeks. The total amount of credits in this study programme is 136, 76 for academic studies, 60 for vocational training.</p> <p>Entry requirements</p> <p>The applicant must have completed a 12 week probation period doing general gardening work as well as completing a part of the compulsory on the job training, before starting the academic part of the studies. If requested, work experience can sometimes replace a part of the pre-studies at secondary level.
